- You will need to complete the Provisional Journeyman Electrical Application & Verification Form and include a passport photo.
- Show proof of completing a 4- hour ORL Class
- \$100 application fee
- Have your Apprenticeship Completion Cert. & have passed WA 01 Exam.
- You will not quality if you had previously been issued a provisional electrical license
- The window to apply is 8/15/2018 to 2/8/2019 and the license expires on 8/31/2021

SAFETY SPOI

First of all, I would like to say "Thank You" for sending me to the Safety Caucus in Chicago. It is a very worthwhile conference and I am very appreciative that I was able to attend.

What we do at home, at work and in our leisure time can contribute to work place incidents. Injuries cost \$200 billion dollars annually. As we work we need to think, "keep our head in the game", to keep from getting injured and becoming a statistic. Injuries can have many contributing causes. Stress, being tired, impaired, repetitive tasks, new tasks, congestion, equipment failure, new to project, etc. Prescription pain medicine is a serious medical concern. There have been several suicides in the IBEW so far in 2018 attributed to opioid prescription pain medicine. Every 15 minutes someone in America dies from an opioid overdose. In the late 1990's the drug companies led the medical community and public to think that prescription opioid pain relievers were not addictive. Healthcare providers began to prescribe more of them on a regular basis. The problem arises from several sources: misused prescriptions; extended time used; increased use during pregnancy. To address this issue, there are hard choices to make. Pain is a problem and the method chosen to relieve it is important. Talk to your doctor about options and side effects.

After a member committed suicide it was troubling that people around the member reflected and recalled that there had been changes in behavior and work practices. Thinking it was a personal matter, they did not want to be intrusive. The importance of involvement cannot be overlooked. When a Brother or Sister has a change in behavior or work practice, please take a minute to ask if there is some way you can help them. Take time to care. Some of the addiction happens over the course of time and the person does not realize there is a problem.

Injury, pain and dependence are real and those suffering need to know they are important and someone does care about them. As a member of IBEW Local 112 it is encouraging to know that I have Brothers and Sisters who care. Thank you and may this encourage each of us to be our "Brothers Keeper".

A MESSAGE FROM THE **BUSINESS MANAGER WORK**

The work picture continues to look very good for Local 112. Dyna and OEG are currently hiring for their projects, and EC at PDX 80 and will be hiring as needed. JH Kelly has been slow, but we saw some calls this month, with ramp up unknown at this time. Power City at the Starbuck pulp mill has ramped up to 22 wiremen so far, with a peak projection of 35-40. WTCC has added a few lately, and some will go to support a night shift. Williams Plant Services is holding steady and starting to plan for the 2019 outage. Hanford area contractors like American, Northpoint, and NW Power are expected to have calls in as jobs are released. Cabin Creek in Ellensburg is aggressively bidding and hopes to capture more work up the Valley. There are currently 49 on Book I and 91 on Book II.

Organizing Report

Local 112 held its annual Organizing Blitz August 14 & 15th This year we decided to target Yakima and the surrounding areas. Our goal is to regain some Union Density/Market Share in these areas. During the blitz, we knocked on 128 doors of licensed 01 electricians. As a direct result, four wiremen have already contacted us and have signed the out of work books. At the blitz, we had Greg Boyd, our International Representative from the Membership Development Department and volunteers from local unions 46, 73, 76, 77 and 191. In addition, we had two retired members, Herb Crockett from Local 73 and 112's Joe Legard donate their time as they recognize the importance of organizing workers into our local union. A special thanks to Jason Lohr, D.J Skone, and J.C Krueger for taking time away from their families and participating with us as well. Because of their participation, we were able to reach out to an additional 20-30 electricians that we would have otherwise not been able to meet with. Thanks to all those who participated!

Originally, we had identified approximately 360 potential new this year. Membership Development members to meet Representative, Rylan Grimes, will be focusing on the Yakima area and plans to meet with the individuals remaining on the list. As you may have guessed, it takes a great deal of effort and planning to host a blitz.

On Wednesday we hosted the Northwest Organizer's meeting. It was reported that the 9^{th} District did not reach our goal of increasing our membership by 4 % this year. As part of our Organizing Action Plan, we have an ongoing obligation to develop a stronger organizing culture in LU-112. As such, we plan to have a Member to Member (M2M) class in the near future. We also hope to conduct M2M blitzes through the rest of 2018 and into 2019. Our hopes are that these efforts will act as a tool to strengthen our organizing culture.
